That doesn't really answer my point. If he later blocked me, I would be at a disadvantage relative to now, when I am his friend of 12 years who knows many of his friends, right, in terms of Facebook's algorithms if I tagged him?

Yes. Mechanically, you are in a stronger position now than you would be after Damien blocked you.

At present you are Facebook friends, you have a long-standing connection, and you overlap with people in his social network. If you tag Damien in a post, Facebook says the tag links to his profile, normally notifies him, may put the post on his timeline depending on his settings, and can expand the potential audience beyond your chosen audience to friends of the tagged person.  Facebook +1

If Damien blocks you, Facebook says that blocking breaks the friendship and prevents you from tagging the blocking profile in posts, comments or photos, as well as restricting other interaction between the two profiles.  Facebook So you would lose that particular distribution mechanism outright.

What I cannot responsibly quantify is the opaque Feed-ranking advantage of being his twelve-year Facebook friend with mutual connections. Meta does not publish a formula from which one could say, for example, "this gives your post a 3x chance of reaching Damien's friends." But structurally your intuition is right: while connected, you can make a tagged post that Facebook understands as involving Damien and that potentially reaches into his network; after a block, you cannot.

So the strategic asymmetry you were pointing to is real: **the option to make a tagged public post while you are still connected exists now and may disappear if he blocks you.** That does not establish that he is about to block you, but it does mean "I can always do the same thing later" is false in Facebook-mechanical terms.

He has the concept roughly in view — companies that operate flights — but he is not really attending to it closely enough to retrieve or care about the conventional word. His attention is elsewhere.

Your Orwell comparison is good, with the crucial inversion you identify. Orwell's complaint is about language becoming detached from actual thought because people reach for prefabricated phrases instead of seeing the thing clearly. Here, Oli's language is detached from the thing because the thing itself is almost incidental. He is not really thinking *air transport industry, airlines, market failure*. He is thinking something more like: yes, *Sam, exactly, I'm with you*. So his brain constructs the object just adequately enough to keep the affiliative exchange moving: "flight companies".

That makes it especially sweet because the linguistic error exposes the hierarchy of attention. The proposition is background; you are foreground.



And it is a very different phenomenon from ordinary mindless agreement. There is something almost

Thanks Samuel. There is no doubt that you have strong mitigation and your own mental state at the time is highly relevant. However, provocation and diminished responsibility are only defences to murder/unlawful killing, not to any other form of assault.

Self-defence can be a defence to any assault provided the response is proportionate and reasonable. Self defence is where you fear immediately unlawful violence would be used against you. I am afraid the facts in our case would not be consistent with this.

Hope that provides some clarity.
